1. SCFB agrees to permit Exhibitor to use and occupy space for the purpose of displaying at The Big Farm Show December 5 & 6, 2019.

2. Space Selection: Each exhibit space is 8' x 10' and includes a 6 ft. skirted table and two chairs. Exhibit fee includes two admissions to the Thursday evening dinner. Complimentary continental breakfast will be provided Friday.

6. Rules and Regulations: Exhibitor agrees to use and occupy rented space for the purpose of exhibiting, subject to the conditions, set forth herein, and to the rules and regulations governing said Exhibit. The exhibit space is leased to SCFB by the Kingston Plantation and this agreement is subject to all the terms, provisions and conditions of said lease.

7. Sales and/or distribution of all goods, products, foodstuffs, etc. shall meet the rules and regulations of the Kingston Plantation and all city, state and county ordinances, statutes and regulations as to disposing of such products, including but not limited to sales taxes and health regulations.

8. Cancellations and Refunds: Cancellation of a contract for space by Exhibitor will result in all loss of monies paid. SCFB may use canceled space as it sees fit. Except as expressly set forth in this Paragraph, SCFB shall make no refunds whatsoever of monies paid or payable pursuant to Paragraph 6. If an Exhibitor's written notice of cancellation is received ninety (90) or more days prior to the opening of The Big Farm Show, and if the SCFB is completely sold out and if the canceled space is re-rented, then and only then shall SCFB refund to Exhibitor the full contract amount less 20% of the full value of the cancelled space. Under no circumstances will a refund be made if cancellation is made less than ninety (90) days prior to The Big Farm Show. Should The Big Farm Show be canceled or postponed by reason of an act of God, strike or other occurrence or event beyond the control of The Big Farm Show, Exhibitor will be refunded only that portion which remains after payment by The Big Farm Show of all expenses and losses caused by such cancellation or postponement of The Big Farm Show.

9. Space Assignment: SCFB reserves the right to refuse space and will act as sole judge of applicability and fitness of exhibits. SCFB will determine the number of booths assigned to exhibitor and also the location of the booths.

10. Space Relocation: All or any part of the space is subject to reassignment and rearrangement by SCFB for the purpose of consolidation of display space, or for virtue of the need of Exhibitor for compressed air, electrical, water drainage, or other services, and the availability, capacity and locations of these services. If Exhibitor is assigned to these spaces but does not require these services, it may be reassigned other space locations at the discretion of the SCFB. The judgment of SCFB with respect to such reassignment or rearrangement of space shall be final, although the total square footage occupied by Exhibitor resulting therefrom shall not be reduced or increased substantially without the consent of the Exhibitor, and, if so reduced or increased the amount of the rental payable shall be appropriately adjusted.

11. Rejection Period: Exhibitor, upon notice of definite space assignment, will be allowed ten (10) days to reject in writing the space definitely assigned. Following the expiration of the ten-day rejection period, no rejection will be permitted or considered. The rejection period extends from the date indicated as the definite assignment until ten days after that date.

The ten-day rejection period set forth in the preceding paragraph shall not apply to an Exhibitor assigned space within ninety (90) days of the opening day of The Big Farm Show. No rejection of space will be accepted from such Exhibitors and no refunds will be made after assignment date.

12. Attending Exhibit Space: Exhibitor agrees to appoint a duly authorized representative to have responsibility for its exhibit, and hereby agrees that said representative, or someone in his place lawfully authorized by him or by said Exhibitor, shall be in attendance at its exhibit during the hours said Exhibit is open as set forth in the rules and regulations.

Exhibitor agrees that it shall not vacate its exhibition and cause removal of exhibit materials or move out its exhibit and its materials prior to the official close of The Big Farm Show. In the event the Exhibitor does so vacate, cause removal, or move out prior to the official close of The Big Farm Show, Exhibitor shall pay SCFB the amount of \$500 in damages.

13. Management Liability: Neither SCFB, nor its agents or employees shall be liable for any damage to the property of or loss of business to Exhibitor or any person using its allocated space, or for any loss by theft or other means of the allocated space, or of its employees, agents, servants, customers, or guests, arising from any cause of matter whatsoever, and Exhibitor, on behalf of itself, its employees, agents, servants, customers or guests, any person using Exhibitor's allocated space, or its employees, agents, servants, customer or guests, expressly releases and discharges SCFB, its officers, employees, agents and servants, from any liability whatsoever, on account of any matter or thing arising out of, incident to, or connected with the said Exhibit, the participation of Exhibitor or the use or occupation of space therein by Exhibitor, its employees, agents, servants, customers or guests.

14. Indemnification: Exhibitor on behalf of itself, its employees, agents, servants, customers and guests will protect, indemnify, and save harmless SCFB against and from any penalty or damage or charges imposed for any violation of any laws or ordinances, occasioned, caused or contributed to by any willful or negligent act of Exhibitor, its employees, agents, or servants. Exhibitor, in behalf of itself, its employees, agents, servants, customers and guests, will at all times protect, indemnify and save harmless SCFB against and from any and all loss, cost, claim, liability, damage or expense arising out of or from any accident or other occurrence in connection with the use or occupation by Exhibitor of said space, causing injury to any person or property whomsoever, occasioned, caused or contributed to by any willful or negligent act of Exhibitor, its employees, agents, or servants.

15. Defaults: If Exhibitor defaults in any of its obligations under this agreement, or violates any of the requirements or covenants of this agreement, including any Rule or Regulation promulgated pursuant to this agreement, SCFB may without notice terminate this agreement, and retain all monies received on account of rental as liquidated damages. SCFB may thereupon, with or without process of law, remove the said Exhibitor, its employees, agents or servants, and all of its articles of merchandise and other personal property from the space contracted for and from the Kingston Plantation.

16. Binding of Contract. This agreement shall not be binding until accepted by SCFB. Exhibitor shall not be entitled to exhibit in The Big Farm Show unless the rental has been paid in full.
