# SC State Legislative Weekly Update - February 5, 2021

### **General Assembly Weekly Highlights**

The General Assembly returned to the Capitol this week for their fourth week of the legislative session to continue their work for the state.

- South Carolina **COVID-19 Liability Safe Harbor** bill (<u>Senate Bill 147</u>) that provides liability protections for healthcare providers and businesses that follow public health guidance in response to the Coronavirus public health emergency passed out of Senate Judiciary Subcommittee with amendments. The bill will now head to full committee for debate.
- A Joint Resolution to make appropriations to the state's response to the Covid-19 response, including vaccinations for our state, was passed favorably with amendments by the Senate Finance Subcommittee. This resolution has already passed the House. The bill will move to the full committee for debate and if passed favorably, will be placed on the Senate calendar for debate on the Senate floor.
- South Carolina Farm Bureau President Harry Ott requested funding from House Ways and Means to assist with the invasive feral hog problem in South Carolina. Since the early 2000s, feral hogs have expanded into all 46 counties of our state. Annually, the economic impact of wild pigs in SC is extensive, causing an estimated \$115 million in damage.
- The Senate confirmed Dr. Edward Simmer as the new Director of South Carolina DHEC.

### **Upcoming Legislative Week**

- House Ways and Means subcommittee meetings will continue with their eye on full committee budget deliberations scheduled to occur the week of February 15. South Carolina's Board of Economic Advisors expect to provide a statewide fiscal update on February 15 that we will be eyeing intensely.
- Legislators are scheduled to return to the Capitol on Tuesday, February 9<sup>th</sup>.

SC Farm Bureau Government Relations will continue to monitor, develop strategy and provide timely updated information on action items when available.

#### New Bills of Interest

#### **New Bills Introduced this Week**

Clemson University State Crop Pest Commission has submitted new regulations related to the <u>Asian Longhorned Beetle Quarantine (ALB)</u>. An Asian LonghornedBeetle quarantine is necessary in South Carolina to aid eradication efforts, prevent additional pest spread and save the many more yet to be affected trees in the state. These new regulations will define the quarantine area and process for containing and eradicating the Asian LonghornedBeetle. There is currently an ALB Emergency Quarantine regulated area in and adjacent to Ravenel, Meggettand Johns Island in Charleston county which can be found <u>here</u>.
