## **Tax Changes Coming?**

House Bill 4880, sponsored by Gary Simrill (House District 46 – York County) and others, moved swiftly through the House this week with a final vote of 112-0 on the floor. The bill was sent to the Senate and immediately assigned to Senate Finance. The bill would create a two-rate plan that would eliminate the current six bracket tax framework and create two main tax brackets, 6.5% and 3%. This reform would be phased in over a five year period and tied to continued revenue growth to offset the realized reduction in tax collections.

## South Carolina Agriculture Tax Exemption (SCATE) Bill on House Floor for Debate

The <u>South Carolina Agriculture Tax exemption (SCATE)</u> bill sponsored by <u>Representative Patrick</u> <u>Haddon</u> (House District 19 – Greenville County) continues to be debated on the floor of the House. The SCATE bill would extend the period of time to file for and obtain the SCATE card, redefine timeframe expiration of the card and limit requested information to obtain the card.

#### **Government Restructuring – S.2**

Senate Medical Affairs Subcommittee <u>Chairman Harvey Peeler</u> (Senate District 14 including Cherokee, Spartanburg, Union and York Counties counties) chaired a committee meeting on Senate Bill 2 this week. The bill focuses on DHEC reform and increasing government efficiency while creating separate health and environmental state agencies, including moving all statewide water into one agency. The bill received overwhelming support with a unanimous vote of 5-0 to move the bill into full committee for consideration.

#### **Full House Budget Deliberations Soon**

House Ways and Means <u>Chairman Murrell Smith, Jr.</u> (House District 67 – Sumter county), along with all committee members, have worked diligently to create the state's budget for FY2023. House Bill 5150 will soon occupy the House calendar for debate, before being to sent to the Senate for consideration.
